### **Design Technology 2021-2022**

Your child will be studying Design Technology as part of their KS3 Curriculum, which will include Food Technology, Resistant Materials, Textiles and Graphics.

A high proportion of the work is practical based, students will be involved in trials and testing, as well as designing and making final products which they can take home - the school provides funding for this, however, we ask for a voluntary contribution towards the cost. We will then provide ingredients/materials for the lesson, meaning that individual students will not be requested to bring in small amounts of flour, sugar, butter, eggs etc, however, on some occasions students are required to supply additional items such as meat or meat alternatives.

I have been able to keep the cost the same as last year despite increasing prices for ingredients and materials in Food, Resistant Materials, Textiles and Graphics, however, I fully appreciate this is an additional cost at a busy time of the year. Should you find difficulty in making the payment, please contact the school's Finance Office to discuss further.

As I am asking for a voluntary contribution, it is important to highlight that the alternative to your contribution would be providing your child with their own ingredients/materials on a weekly basis and relenting to do so would result in your child not being able to develop practical skills as planned. I feel that the contribution system has worked well in previous years and offers good value for money, however, its success relies on a high level of response. Without contributions I would have to follow the system used by other schools where students bring all ingredients every week.

If you would prefer not to make a contribution and supply all of the ingredients/materials yourself each week, please sign the slip attached acknowledging this. If this option is selected, your child will be responsible for collecting a recipe sheet on a weekly basis and any missing ingredients would prevent them from being able to participate in the practical lesson.



I am concerned for students' safety in all areas of Design Technology. Appropriate footwear is vital in practical areas. Shoes need to be flat and cover the top of the foot. A growing number of students have **allergies or intolerances**. Prior knowledge of this enables staff to plan alternatives. Please complete the reply slip accordingly.
